



WHY THIS SEARCH IS UNIQUE



A search for a copy of the Title Register is normally straight forward, being based on a property's postal address or on the Title Number. However, for properties where there is no postal address, e.g. a field, it is impossible to search in a database for it. Such properties are often described as "The Freehold land shown edged with red on the plan of the above Title filed at the Registry and being land on the west side of Greater Avenue, Tanner, Worcestershire". Clearly it is not going to be possible to search in a database for an address such as this.
